



Polasaí Scoile i Leith Gutháin Phóca

Déanadh an polasaí seo a leanas a dhréachtadh i gcomhar leis an bhFoireann Teagaisc, Bord Bainistíochta agus Comhairle na dTuismitheoirí. Tá glactha leis anois mar pholasaí úsáide agus rachaidh sé i bhfeidhm ar an **DÁTA**. Déanfar an polasaí a athbhreithniú go rialta i gcomhar leis na páirtithe thuasluaite.

1. Tá cead ag daltaí guthán póca a bheith ina seilbh acu ar scoil má chlaíonn siad leis an bpolasaí úsáide agus má bhíonn foirm cheadaithe an tuismitheora/an chaomhnóra i seilbh na scoile.
Seo a leanas na coinníollacha eile ar a gceadaíotar gutháin phóca sa scoil:
 - i Caithfear an guthán a bheith múchta sara dtagann an dalta isteach sa scoil agus é a choimead múchta i gcaitheamh an lae sa scoil. I gcás imeachtaí taobh amuigh den scoil – turas scoile, lá spóirt, snámh srl. bíonn an éifeacht chéanna leis an bpolasaí ar na hócáidí seo. Ní ceadmhach an guthán a chur ar siúl arís go dtí go mbíonn an scoil fágtha ag na daltaí.
 - ii Caithfidh na daltaí an guthán a fhágáil ina mála scoile. Níl sé ceadaithe gutháin a thógáil go dtí an clós ná chuig na leithris srl.
 - iii Más gá do thuiste/caomhnóir teachtaireacht phráinneach a sheoladh chuig a bpáiste i gcaitheamh an lae scoile – iarrtar orthu guthán oifige na scoile a úsáid chuige seo.
 - iv Má bhriseann dalta na rialacha seo trí an guthán a bheith ar siúl acu sa scoil nó guthán a bheith ina seilbh gan an fhoirm cheadaithe a bheith tugtha don scoil, tógfar an guthán ón dalta ar feadh tréimhse coicíse agus caithfidh tuiste nó caomhnóir é a bhailiú ón scoil i ndeireadh an tréimhse sin.
Cuirfear in iúl i scríbhinn don tuiste/caomhnóir má bhriseann dalta na coinníollacha thuasluaite agus an data ar a mbeidh cead an guthán a fháil ar ais ón scoil.
2. Ní bheidh údarás na scoile admhálach ná freagrach as aon ghuthán a thugann dalta chuig na scoile.
3. Níl cead i gcás ar bith ag daltaí guthán camera a bhreith chun na scoile.

Baineann contúirt áirithe le guthán póca a bheith feiceálach i seilbh daltaí ag taisteal chuig/ón scoil. Iarrtar ort an chontúirt seo a phlé leis an dalta agus comhairle a chur air/uirthi.

Beidh an polasaí seo i bhfeidhm ón **DÁTA**. Ní mór an fhoirm cheadaithe a bheith seolta ar ais chuig an scoil roimh an data sin.

Iarrtar ort an fhoirm thall a chomhlánú agus a sheoladh ar ais chun na scoile láithreach bonn.

Mobile Phone Policy

The following policy regarding mobile phones has been drafted and sanctioned by the Board of Management for Gaelscoil Thulach na nÓg. It was also presented to the Parents Committee where it was also accepted.

Therefore any pupil bringing a mobile phone to school must adhere to the conditions as set out below. This policy is subject to occasional review.

1. Pupils are only permitted to have mobile phones in school provided that a permission slip has been satisfactorily completed and returned to the school.
2. The conditions under which pupils are allowed to bring a mobile phone to school are as follows:
 - i Pupils' phones must be switched off before entering the school and must remain off during school hours. This includes school based out of school activities. Phones may only be switched on again once the pupil has left the school for the day.
 - ii Phones must be kept in the pupil's schoolbag. They are not to be brought out to the yard/toilet etc.
 - iii The school recognises that parents may need to get messages to pupils. The school phone line should be used in all instances.
 - iv If a pupil breaks these rules either by having a phone switched on OR by bringing a phone to school without having returned a signed permission slip, that pupil's phone will be confiscated for 2 weeks and must be collected after that time by a parent/guardian.
The pupil's parent/guardian will be notified of this in writing and also of the date on which the phone may be collected.
3. The school accepts no responsibility for any phone brought into the school.
4. Under no circumstances are pupils permitted to bring camera phones to school.

Parents are requested to bring to the attention of their children the dangers involved with having their phone on view when travelling between the home and school and to advise them on how best to avoid any unwanted attention as a result of having a phone.

This policy will come into effect from **DÁTA**. As such all permission slips must be signed and returned before this date.
